Regular meeting of December 7, 1961

The regular meeting of the Western Dubuque County Community School Board was held on Thursday eve. December 7, 1961 at the office of the district at Farley. Meeting called to order by the President Mr. Driscoll at 8 P. M.

Minutes of the last regular meeting were read, there being no additions or corrections they were approved as so read.

At this time Mr. Herman Feldman and Mr. John Merges of Centralia Iowa, located in Center Twp. school district, met with the board. These gentlemen stated they were representing the parents and residents of their vicinity who wished to become a part of the Western Dubuque County Community School Dist. Many of the parents they represented now have tuition students attending Western Dubuque County Community Schools. Mr. Feldman and Mr. Merges were told they have to effect a release from their own school board, and if this were obtained the Western Dubuque County Community School Board would do what they could to have this territory attached to the district.

Mr. Buchman, principal, appeared at the meeting telling of the visit of the deputy fire marshal of the State Department of Public Safety to the Epworth school building. The recommendations for fire prevention and safety at this building are being compiled with. The deputy fire marshal had also visited the Farley school building. In view of the fact the addition is being built at this time the recommendations would be inspected at the time the construction is completed.

Correspondence received from the State Department of Public Instruction, granting the district's request for waivers on courses of study not offered by the district, by the terms of Standard 40.

A statement received from the Cullen-Schiltz firm in the amount of \$4,647.10. This includes the amount from the statement read at the

November meeting, which included the bill from Warzyn Engineering firm. A motion by Scherrman that this bill be paid, with the understanding that: negotiations be made with the architectural firm of Durrant and Bergquist to regain the amount of the initial payments made by the district to Cullen and Schiltz for borings at the site of the new junior-senior high school. The motion seconded by Ross, motion carried unanimously.

A letter read from Cullen=Schiltz and Associates stating that the contractors doing the grading work at the junior-senior high school site at Epworth asked for permission to discontinue grading operations this fall and complete the work next spring, with the suggested completion date being May 15, 1962. Motion by Scherrman that this permission be given, with May 15, 1962 as the completion date. Motion seconded by Recker and carried unanimously.

Approval received from the State Department of Health for the water supply facilities at the Bernard elementary school.

A motion by Ross that change order no 1 on the Bernard elementary school in the amount of minus \$180.00 be granted. Motion seconded by Deutmeyer 2nd carried unanimously.

A motion by Ross that the settlement agreement with E. J. Freeman, that is: Freeman Electric of Independence Iowa be signed, and record of this in the amount of \$56,860.00 be made. Motion seconded by Scherrman and carried unanimously.

Motion by Deutmeyer that the Floyd school property described as follows:

An offer to purchase the St. Mary's rural school, section 4, Whitewater Township for \$50.00 from Robert McAllister was tabled for the present. The Board recommended that Mr. McAllister be notified that the property might be purchased for \$75.--
