You are hereby notified that a meeting of the Board of Directors of the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, will be held on the 25th day of April, 1961, within said School District, at the office of the district, at the Farley Public School Building at 8 o'clock p. m. for the purpose of considering and acting on a petition which was filed with the undersigned on the 21st day of April, 1961, asking that an election be called to submit to the voters of said School District, to be by them voted upon, the proposition of issuing bonds of said School District in the amount of \$1,333,500 for the purpose of carrying out a school building program consisting of building and furnishing a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley Iowa, and procuring sites therefor in and for said School District, and the proposition of issuing bonds of said School District in the amount of \$11,500 for the purpose of building a school bus garage in and for said School District, and for the transaction of such other business as may come before the meeting,

The meeting was called to order by the President, and, the roll being called, there were present Harold Driscoll, President, in the chair, and the following named Directors:

The President read the foregoing call and reported that service thereof as above stated had been duly made and accepted and presented the petition referred to in said call.

Whereupon the Board examined and considered said petition and found said petition to be legal and sufficient and to bear the requisite signatures.

Director Irvin Recker introduced and read the resolution next hereinafter set out and moved its adoption, seconded by Director LaVerne Deutmeyer, and after due consideration thereof by the Board, the President put the question upon the adoption of said resolution and, the roll being called, the following named Directors voted:

Whereupon the President declared said resolution duly adopted as follows:

RESOLUTION

Whereas there was filed with the President of this Board of Directors on the 21st day of April, 1961, and has been presented to this board of Directors a petition requesting that an election be called on the question of issuing bonds of this School District in the amount of \$1,333,500 for the purpose of carrying out a school building program consisting of building and furnishing a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley, Iowa, and

procuring sites therefor in and for said School District, and on the question of issuing bonds of said School District in the amount of \$11,500 for the purpose of building a school bus garage in and for said School District: and

Whereas said petition is signed by qualified voters of the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, in number equal to more than twenty-five per cent of those voting at the last election of school officials in said School District, and said petition is in all respects sufficient and complies with the provisions of Section 296.2 of the Code of Iowa, 1958, as amended, and this Board has jurisdiction thereof and said petition should be granted; and

Whereas it is necessary that said School District build and furnish a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley Iowa, and procure sites therefor, and that said School District build a school bus garage, as hereinbefore recited, and the indebtedness necessary to be incurred to defray the cost of carrying out said school building program and building said school bus garage will be in excess of one and one-quarter per cent of the assessed value of the taxable property within said School District; and

Whereas registration of voters is not required for elections held in said School District and the election precincts hereinafter described account for all of the area within the boundaries of said School District:

Now, Therefore, Be it Resolved by the Board of Directors of the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, as follows:

Section 1. That a special school election is hereby called and ordered to be held in and for said School District on the 25th day of May, 1961, at which there shall be submitted to the voters of said School District the following propositions, to wit:

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of One million, three hundred and thirty-three thousand, five hundred dollars (1,333,500.00) for the purpose of carrying out a school building program consisting of building and furnishing a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley, Iowa, and procuring sites therefor in and for said School District?

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of Eleven thousand, five hundred dollars (\$11,500.00) for the purpose of building a school bus garage in and for said School District?

Section 2. That for said election said Community School District shall be divided into twelve election precincts as follows:

- Precinct No. 1. All of that portion of said School District lying within Jefferson, Township and Concord Township, in Dubuque County, Iowa, and the polling place for said election precinct shall be at Leo Brecht's Barber Shop in the Town of Holy Cross, Iowa.
- Precinct No. 2 All of that portion of said School District lying within Liberty Township in Dubuque County, Iowa, and the polling place for said election precinct shall be at the Holy Trinity School in the Town of Luxemburg, Iowa.
- Precinct No. 3 All of that portion of said School District lying within Colony Township and Bremen Township in Delaware County, Iowa, and the polling place for said election precinct shall be at the Parish Hall in the Town of Petersburg Iowa.
- Precinct No. 4 All of that portion of said School District lying within the New Vienna Precinct of New Wine Township, in Dubuque County, Iowa, and the polling place for said election precinct shall be at the New Vienna Town Hall in the Town of New Vienna, Iowa.

- Precinct No. 5 All of that portion of said School District lying within the Dyersville Precinct of New Wine Township, in Dubuque County Iowa, and the polling place for said election precinct shall be at the Memorial Hall in the Town of Dyersville, Iowa.
- Precinct No. 6 All of that portion of said School District lying within Iowa Township in Dubuque County, Iowa, and the polling place for said election precinct shall be at the Bankston Parish Hall in the Town of Bankston, Iowa.
- Precinct No. 7 All of that portion of said School District lying within Vernon Township in Dubuque County, Iowa, and the polling place for said election precinct shall be at the Peosta High School in the Town of Peosta Iowa.
- Precinct No. 8 All of that portion of said School District lying within Center Township and within the Epworth Precinct of Taylor Township, all in Dubuque County, Iowa, and the polling place for said election precinct shall be at the Epworth Town Hall in the Town of Epworth, Iowa.
- Precinct No. 9 All of that portion of said School District lying within the Farley Precinct of Taylor Township and within the Farley Precinct of Dodge Township, all in Dubuque County Iowa, and the polling place for said election precinct shall be at the Farley Memorial Hall in the Town of Farley Iowa.
- Precinct no. 10 All of that portion of said School District lying within the Worthington Precinct of Dodge Township in Dubuque County, Iowa, and within North Fork Township and South Fork Township in Delaware County Iowa, and the polling place for said election precinct shall be at the Worthington Town Hall in the Town of Worthington Iowa.

Precinct No. 11 All of that portion of said School District lying within Cascade Township and Whitewater Township in Dubuque County Iowa, and within Richland Township and Washington Township in Jones County Iowa, and the polling place for said election precinct shall be at the Cascade Memorial Hall in the Town of Cascade Iowa,

Precinct No 12 All of the remaining area within the boundaries of said School District, including all of that portion of said School District lying within Prairie Creek Township and Washington Township in Dubuque County, Iowa, and within Butler Township in Jackson County, Iowa, and the polling place for said election precinct shall be at the Bernard Fire House in the Town of Bernard Iowa.

The polls for said election shall be kept open from seven o'clock a. m. until seven o'clock p. m.

Section 3. That the Secretary of the Board of Directors is hereby authorized and instructed to issue a notice of said election on said proposition and of the time and places thereof by publication of such notice in the Dyersville Commercial and Cascade Pioneer, legal newspapers published in said School District and having a circulation (general) therein, once each week for at least four consecutive weeks, the last of which publications in said newspaper shall be not less than five nor more than twenty days before the date fixed for said election.

Section 4. Both of said propositions shall be submitted on the same ballot with one inch of clear space between the two propositions, and the Secretary of the Board of Directors shall have the ballots to be used for voting on said propositions at said election prepared on yellow colored paper, in substantially the following form, with the facsimile signature of the Secretary in the space provided therefor on the back of each ballot:
