RESOLUTION canvassing and declaring the results of election on school building bond and school bus garage bond propositions.

WHEREAS pursuant to petition and a resolution heretofore adopted by this Board of Directors of the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson Jones and Delaware, and State of Iowa, there was submitted to the voters of said School District at a special election held on May 25, 1961, to be by them voted upon, the following propositions:

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of One million, three hundred and thirty-three thousand, five hundred dollars (\$1,333,500.00) for the purpose of carrying out a school building program consisting of building and furnishing a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley, Iowa, and procuring sites therefor in and for said School District?

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of Eleven thousand, five hundred dollars (\$11,500.00) for the purpose of building a school bus garage in and for said School District?

WHEREAS said election was duly called and held on said date and the Judges and Clerks of said election have filed their

returns which have been duly examined and verified;

NOW, THEREFORE, Be It Resolved by the Board of Directors of the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson Jones and Delaware, and State of Iowa, as follows:

Section 1. That upon being duly advised in the premises it is hereby found and declared that at the election referred to in the preamble hereof there was duly submitted the following proposition:

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of One million, three hundred and thirty-three thousand, five hundred dollars (\$1,333,500.00) for the purpose of carrying out a school building program consisting of building and furnishing a junior-senior high school building at Epworth, Iowa, elementary schoolhouses at Cascade, Bernard and Dyersville and an addition to the elementary schoolhouse at Farley, Iowa, and procuring sites therefor in and for said School District?

and that at said election on said school building bond proposition there were cast 4764 ballots, of which 3639 votes were cast "Yes", 1105 votes were cast "No", and 120 ballots were cast blank or defectively marked on said proposition.

Section 2. That a record of the votes cast on said school building bond proposition at said election by precincts is hereby made as follows:

That it is hereby found and declared that the vote cast in favor of said school building bond proposition at said election was equal to at least sixty per cent of the total votes cast for and against said proposition at said election and that said proposition is hereby declared to have been duly carried and adopted.

Section 4. That upon being duly advised in the premises it is hereby found and declared that at the election referred to in the preamble hereof there was duly submitted the following proposition:

Shall the Western Dubuque County Community School District, in the Counties of Dubuque, Jackson, Jones and Delaware, State of Iowa, issue bonds in the amount of Eleven thousand, five hundred dollars (\$11,500.00) for the purpose of building a school bus garage in and for said School District?

and that at said election on said school bus garage bond proposition there were cast 4549 ballots, of which 3170 votes were cast "Yes" , 1260 votes were cast "No" and 109 ballots were cast blank or defectively marked on said proposition.

Section 5. That a record of the votes cast on said school bus garage bond proposition at said election by precincts is hereby made as follows:

That it is hereby found and declared that the vote cast in favor of said school bus garage bond proposition at said election was equal to at least sixty per cent of the total votes cast for and against said proposition at said election and that said proposition is hereby declared to have been duly carried and adopted.

Section 7. That it is hereby found and declared that the total number of ballots cast at said election, as shown by the poll lists, is 4764.

Section 8. That this resolution be entered of record and constitute the findings and declaration of this Board of Directors of the results of said election on the propositions as hereinbefore set out.
