Superintendent Drexler present, also Mr. Mark Brady of the Herard Insurance Agency. The insurance program of the district was discussed and Mr. Brady, agent of record for the district was instructed to proceed with renewals on the insurance policies, with fire insurance policies to be on a five year, annual pay premium.

After much discussion Ross moved that the bill that had been presented the board from the St. Francis School District, for labor at the school grounds previous to reorganization, in the amount of \$250.00 be paid, the motion seconded by Deutmeyer and carried unanimously.

Superintendent Drexler reported on progress that had been made toward the disposal of the rural school sites. Ross moved that the board adopt a resolution that: conferences having been held with the owner of the land from which the school site was taken and prices found to be reasonable on the following school sites, final plans be made for their disposal:

The board authorized Superintendent Drexler to start the preparation of a school board policy. This to be presented to the board for approval at a later date.
