<u>Principals Reports</u>: Reading and Math goals at the Cascade and Bernard schools were met. Student lead conferences will be studied for use at Cascade/Bernard. Lock down drills at the schools is under way. Parent teacher conference attendance is up. DMS play production was deemed a success. Farley elementary carnival is planned for April 19th. End of school year activities are being planned. Drexler MS grades 7 & 8 will be going to the House Concept (teachers share the same students) of teacher assignments for next year.

<u>Cascade/Bernard Elementary Building Highlights</u>: Jane Boffeli, Cascade Elementary instructor provided the Board an overview of the 1st year implementation of the Positive Behavioral Interventions and Supports Program (PBIS) at the Cascade/Bernard schools. Topics included – main purpose of program, teaching and learning, staff training, expectations, activities, student perspective, corrective consequences and responses to intervention.

Superintendent Report: Mr. Corkery advised the Board that at the May School Board meeting he will be presenting a change to the attendance boundary for the Cascade and Bernard elementary schools. He noted that attendance waivers, class sizes, parent concerns, transportation issues along with other practical considerations are reasons for considering a change in the line. The district's new plan on a page and scorecard will be presented at the May meeting. Dr. Jay Marino will be returning to the District to meet with building leadership teams to strengthen and enhance the District's Continuous Improvement Program. Special thanks to the important role that the Our Future Now committee had in the successful passage of the 04-03-2012 Bond and PPEL vote. The Board Facility Committee will be meeting in the near future to discuss the planning and coordination needed for the approved building projects including committee duties, project manager issues and public input.

Physical Plant & Equipment Levy:

Shall the Board of Directors of the Western Dubuque County Community School District, in the Counties of Dubuque, Clayton, Delaware, Jackson and Jones, State of Iowa, be authorized to levy an annual physical plant and equipment levy upon all taxable property in said School District, said levy not to exceed \$1.00 per thousand dollars of assessed valuation in any one school year, for a period of ten (10) years, commencing with the levy to be made for collection in the fiscal year which begins July 1, 2012, the money received from the levy shall be expended only for those purposes now or hereafter authorized by Iowa Code Chapter 298?
