Principal Reports:

Topics discussed were: School start-up activities, Building Leadership Team meetings, parent communications, DRA awards, building construction, paraprofessional attendance at teacher PBIS training meetings, parent/teacher meetings, extended school day student opportunities, DMIS master schedule tailored to student and staff improvement programs, 20th anniversary of the addition to the Farley Elementary building, enrollment numbers, appreciation to classified staff for summer work in preparation for school start, new Alternative School location and program, WDHS instructor Tom Danner recognized as Student Council Advisor of the year, Web based IEP program for special needs students and new teacher training.

Annual Yearly Progress Report:

The No Child Left Behind Act (NCLB) of 2001 requires each district and school to annually demonstrate adequate yearly progress towards meeting the state academic annual measurable objectives, participation rate, and other academic indicators goals for grades 3-8 and grade 11. Kelly Simon, Director of Curriculum and Assessment provided the Board with this required information in the required reporting areas of Reading, Math and Science showing both targets reached and targets missed.

Food Service Report:

Sherry Kaiser, Director of Food Services provided the Board information on Offer versus Serve Menus that will be used in the elementary schools starting in the 2013-14 school year. Offer vs. Serve (OVS) is a serving method designed to reduced food costs and waste as well as allow students the opportunity to make choices in the foods they intend to eat. By law, OVS is required for senior high school grades (grades 9-12) for lunch. For grades below senior high school, OVS can be designated for any grade level and/or meal service. Students are allowed to select all items, if they so desire, for the same unit price. OVS is currently used for all middle and high school students, both on the main line and through a la carte. The District will receive an additional 6 cents per meal reimbursement from the federal government for the program.

Superintendent Report:

- Cascade and WDHS student councils receive recognition by state association.
- Enrollment projected to be up slightly.
- Staff school start-up meetings underway.
- New school year will see significant time spent on new State Education Reform legislation.
- Preparations for the District's five-year Dept. of Education review will begin this year. Review is scheduled for the 2014-15 school year.

A Level 1 investigator is a person who initially investigates general allegations that a school employee may have abused a child in the course of that individual's employment. The Iowa Legislature in 1989 required all schools in the State to adopt a uniform procedure for investigating such allegations.
- 5. Approve Utility Easement Cascade Elementary: Motion by Knuth, second by Coppola to approve the underground electrical easement at the Cascade Elementary site to Cascade Municipal Utilities. Motion passed 5-0.
